SUBJECT: LEASING - MAIN CORNER COMMERCIAL KITCHEN

Ref: AF11/2260

Goal: Governance

Strategic Objective: Demonstrate innovative and responsible organisational governance.

Council has received a request from the Company Directors of 'Sorrentos at the Main' as Lessee of the Main Corner Commercial Kitchen for consent to be granted to a proposed transfer/disposal of 50% of the company shares from one Director to a new Director.

Such a transaction is a deemed assignment under the Lease and Council consent must first be obtained prior to the transfer.

Members may recall granting consent to an identical transaction associated with this lease approximately 2 years ago, conditional upon the outgoing shareholder only being released from a personal guarantee after the maximum period allowed under the Retail & Commercial Leases Act.

Council should note it has limited grounds upon which to refuse to grant consent to the transaction, being deficiencies in the experience or financial position of the incoming shareholder in comparison to that of the exiting shareholder.

Council's Governance Officer and Chief Executive Officer have undertaken a due diligence assessment including a review of the Business & Financial Plan and the Curriculum Vitae and financial status of the incoming shareholder/Director. The Governance Officer and Chief Executive Officer are satisfied that Council's risk will not vary significantly by consenting to the share transfer and deemed assignment, provided a personal guarantee is maintained with the outgoing shareholder/Director for the maximum allowable period of 2 years.

Members may also recall that the previous transaction was delayed due a lack of a quorum at the Council meeting when the matter was first presented for consideration due to the declaration of several Conflicts of Interest by Members in relation to the agenda item. A potential repeat of this situation has been raised as a matter of some concern by the Lessee as for business reasons they are keen to progress this matter without any unnecessary delay.

Members should also note that this issue is not a designated decision or significant decision prohibited by the Local Government Act 1999 or Council's Caretaker Policy.
