1. <u>ENVIRONMENTAL MANAGEMENT</u> - Renewable Energy Options Investigation - Mount Gambier Library Solar System - Ref. AF11/407

Goal: Environment

Strategic Objective: (i) Systematically build Council as an environmentally sustainable

The Presiding Member reported:

(a) At the 18th March 2014 Council meeting the following resolution was adopted:

"Subject to an allocation in the 2014/2015 adopted Budget, Council release a tender for the installation of a possible lease arrangement solar power system on the entire roof of the Library."

A [draft] tender has now been prepared and the specification details of the draft contract were attached to the Environmental Sustainability Sub-Committee agenda;

(b) the tender is for a lease-to-own arrangement only. The rationale behind this is that the savings in electricity costs are matched by the lease payments, meaning that there is no net impact on both the operational budget and the capital budget. Lease payments are typically made for 5-7 years, after which the solar system would be owned by Council. From the point that the final lease payment is made, all savings on electricity present

financial savings on Council's operating costs. Savings could be over \$30,000 per year and potentially over \$900,000 over a 20 year period;

(c) the topic is being re-presented to Council as the wording of the 18th March 2014 resolution requires clarification. As stated above, the purpose of pursuing a lease-to-own arrangement is so savings on electricity costs can pay for the solar system, and so have no net impact on the budget. Council will not know the exact impact on the budget until it receives firm prices through an open tender process.

Cr Smith moved it be recommended:

- (a) The report be received;
- (b) Council proceed to release an open tender for a lease to own solar system for the Mount Gambier public library, and following the tender process a further report is to be presented to Council.

The Presiding Member reported:

- (a) At the 28th January 2014 Council meeting it was resolved to develop an EOI for the operation of a materials recovery facility (salvage yard) at Council's 3 Eucalypt Drive site, then have Find Workable Solutions (FWS) and Future Employment Opportunities (FEO) review the EOI before final release;
- (b) the EOI has been developed and reviewed by FWS and FEO, and a copy of the EOI was attached to the Environmental Sustainability Sub-Committee agenda;
- (c) following the close of submissions responses will be collated for review by an assessment panel. It is proposed that the assessment panel be made up of the Presiding Member of the Environmental Sustainability Sub-Committee, Director Operational Services, Governance Officer, Environmental Sustainability Officer and a Zero Waste staff member to be nominated by Zero Waste SA;
- (d) the assessment panel will bring a recommendation back to Council.

4. <u>ENVIRONMENTAL MANAGEMENT</u> - Unconventional Gas Mining - Ref. AF14/38

Goal: Environment

Strategic Objective: (i) Support initiatives that value and preserve our unique

environment and contribute to environmental sustainability

Cr Mutton moved it be recommended:

- (a) The City of Mount Gambier opposes the possible unconventional gas exploration and operations within the South East region of South Australia;
- (b) Council calls on the State Government to impose a moratorium on unconventional gas exploration and mining (including hydraulic fracturing) in the South East to enable detailed analysis and community understanding of the issues involved, particularly:
 - 1. Environmental risks for use and contamination of surface and underground water resources, and the use and application of harmful chemicals
 - 2. Geological risks associated with hydraulic fracturing
 - 3. Impact on land use, and potential impacts on agricultural industries and food security
 - 4. Social and personal impacts (such as those already evident in Eastern states)
 - 5. Potential impact on tourism and related industries
 - 6. Potential impact on the Premier's Clean Green Food strategy which has been identified within the State Strategic Plan as one of the key economic drivers
 - 7. The applicability of existing State Government regulations to the South East region

- (c) Council calls on the State Government to recognise that there is a strong case for adopting different regulations regarding unconventional gas mining in the South East, respecting both community sentiment and the potential risks this technology poses for the region;
- moratorium to allow careful independent analysis and advice.
