

The aims of this initiative is to provide a level of financial support to junior(s) who (in the view of the Member Organisation) demonstrate exceptional potential be a success in their chosen sport and could benefit from the financial support to advance their potential but are presently disadvantaged due to the financial limitations of the family;
(ii) How a Member Organisation might interpret whether a particular junior is financiall disadvantaged will be difficult. There is no precedent to give guidance, however the Committee suggests that each Member Organisation use its judgement, observation knowledge of the junior (and the family) and local experiences and beliefs to identify a junio who appears to be disadvantaged and who could further excel with some support.
The assessment is not an exacting science - best judgements is all we can ask.
