2. <u>PROPERTY MANAGEMENT</u> – Compliance – Lake Terrace Cemetery – Licence Permits (Permits/Works on Graves) – Application by South East Monuments and Memorials – Miles Memorial - Ref. AF11/1386

The Secretary reported:

- (a) South East Monuments and Memorials made application to place a monument on a pre-leased allotment at Section J of Lake Terrace Cemetery, which was declined by the Trust on 24<sup>th</sup> February 2017.
- (b) South East Monuments and Memorials have since appealed the Trust's decision to Council, and Council has requested the Trust to reconsider the application.

- (c) Mr Dean Coclonis (South East Monuments and Memorials) and Mr Michael Miles will be attending the meeting to discuss the matter.
- (d) Lake Terrace Cemetery is identified as a Place of Local Heritage Value within the City of Mount Gambier Development Plan.

The extent of the listing includes Sexton's Cottage, two pairs of entrance gates and grave stones and grave site enclosures.

As identified within the City of Mount Gambier Heritage Survey August 1994, the Lake Terrace Cemetery Reserve is an important record of the population of Mount Gambier from the time of its use for internment in 1868. There is no earlier cemetery still in Mount Gambier and this cemetery holds the relics of many significant early settlers.

The cemetery contains excellent examples of early cast and wrought iron grave railings set into dressed limestone and less commonly basalt plinths. The early graves date from 1868 to the 1890's. The periods of burial are clearly distinguishable and new graves have not been allowed to intrude upon the character and early sections of the cemetery. The stepped character of the cemetery up the hillside add to the physical charm and character of the cemetery.

- (b) the Trust reaffirms its decision to decline the application by South East Monuments and Memorials (on behalf of Mr Michael Miles), to construct a monument at Lake Terrace Cemetery on the following basis:
  - The proposed design is considered to be a modern interpretation of what is appropriate as a cemetery monument.
  - The proposed monument would intrude upon the character and early section of the cemetery.
  - The proposed monument would create visual interference to the aesthetic character and appearance of a cemetery that has historical value.
  - The proposed monument does not maintain of reflect the traditional design and pattern of existing monuments.
  - The monument is not consistent with the heritage value, character, style, theme and interpretation of existing monuments and the cemetery reserve.

- The proposed monument detrimentally impacts upon the nature and sensitivities of other gravesites and historic character of the cemetery.
- The design of the monument does not respect the rights of other gravesites, lot owners and their heirs.
- The design of the monument detracts from the aesthetic character of the Lake Terrace Cemetery and is not considered appropriate.
- The proposed monument is not sympathetic to the context of its setting with regard to shape, design and appearance.
- The proposed monument is not sensitively designed and would become a dominant, stand out feature and would detract from the historic character of the Cemetery Reserve.
- The monument as proposed is not appropriate to the style and period of the cemetery and is incompatible with the historic character of the cemetery.
- The monument does not contribute towards the existing character of the cemetery.
