Basketball is the applicants only sport which he enjoys. It is not just the basketball but the opportunity to socialise with his peers and it is an important break from his home environment.

ASSUME MAXIMUM DONATION IS \$300 – HOW WILL DONATION BE USED?

This donation will be used to purchase new shoes, pay Association Registration Fees and also match payments.

(ii) APPLICANT 2


