1. <u>ENVIRONMENTAL MANAGEMENT</u> - Project Management - Rain Garden 500 - Ref. AF11/407

Goal: Environment

Strategic Objective: (i) Systematically build Council as an environmentally sustainable

organisation

The Environmental Sustainability Officer reported:

- (a) Rain Garden 500 is part of a South Australian Environment Protection Authority (EPA) Catchment to Coast project, funded through the Australian Government National Landcare Programme. It is a three-year grant program where local governments, community groups, schools, sports clubs and groups of motivated individuals can apply for funding to build a rain garden in the Adelaide region. The purpose of the rain gardens is to improve the quality of stormwater from streets and other hard surfaces, such as car parks, before it travels to waterways and the sea;
- (b) the program is designed to fund the construction of rain gardens incorporating WSUD principles in the Adelaide region (only) for projects between \$3,000 to \$50,000. The program is designed to build an understanding in the community of how the actions we carry out on land impacts the water quality in urban waterways. It also focusses on improving the water quality in urban areas. The program is currently limited to the Adelaide area;

- (c) given the sensitive and fragile water systems in the South East, the same protection principles apply, as does the need to raise community awareness in protecting our waterways (wether above or below ground). The broader principles apply to all of South Australia and therefore the funding should be available to all;
- (d) it is recommended that Council write to the State Government requesting that this funding program is opened up to the rest of South Australia;
- (e) the City of Mount Gambier have previously demonstrated a commitment to WSUD with numerous projects throughout the city, and would look to implement more projects if further funding opportunities were available.

- (b) Council write to Ian Hunter MLC, Minister for Sustainability, Environment & Conservation, and to Troy Bell MP, Member for Mount Gambier requesting that the Rain Garden 500 program be expanded to include the rest of South Australia, especially the South East.

Goal: Building Communities

Strategic Objective:

- (i) Strive for an increase in services and facilities to ensure the community has equitable access and that the identified needs of the community are met
- (a) At the council meeting held on 21 April 2015 Council passed the following resolution:

"Council invite Dr Steb Fisher to a half day workshop for all Council Members and appropriate staff to revisit the Natural Step Framework and provide a general overview of the framework to Council Members and staff."

- (b) this workshop occurred on the 30th of June 2015, and was well received by those members and staff who attended. Dr Steb Fisher gave a summary of the Natural Step Framework and how it can be applied at the Council level, as well as a thought-provoking summary of some of the major environmental issues facing us today;
- (c) following on from this workshop, Council passed the following resolution at the 21 July 2015 Council meeting:

"Council provide a further seminar with Dr Steb Fisher for a day session on the Natural Step Framework. Council extend an invitation to District Council of Grant to attend."

The purpose of this follow up session is to explore the Natural Step in greater detail, and workshop concrete ideas on how the City of Mount Gambier can further implement it;

(d) it is proposed to firstly repeat the 30 June session, for those Members who missed it – then hold the follow up session. Members who attended the 30 June session do not have to attend the 'catch up' session. In summary, two 4 hour sessions are proposed – the 'Catch up' session, and the 'Follow up' session.
