- (b) the expression of interest phase of this report is due to commence this week and is recommended the Project Advisory Panel for the project consists of the following:
 - City of Mount Gambier 1 representative plus 2 elected Council Members
 - Local History Group 1 representative,
 - Riddoch Art Gallery 1 representative,
 - Arts SA 1 Art for Public Places representative, should Arts SA funding be allocated.

The Project Advisory Panel role will be to:

- be available to provide advice regarding specific concept design development issues relevant to their expertise,
- select the artists/artist teams/illustrators to undertake the design proposal stage,
- assess the concepts and recommend to the City of Mount Gambier Railway Lands Sub Committee the successful artist to undertake the commission.
- (c) Council staff will assess the recommended design proposal in relation to practical issues such as risk management, public safety and maintenance and provide appropriate advice.

The Manager - Regulatory Services reported:

(a) Original contract sum

1. Additional remediation of contaminated materials found onsite above original investigation volumes

\$22,458

\$389,609

2. Screening of railway ballast to use as part of wetlands / creek, rail corridor in lieu of importing materials to site

\$19,870

3. Importation of clean fill to site to fill in low spots created by ballast removal

\$37,159

Final contract sum

\$461,237.07

(b) Comment - Items 2 and 3 were not part of dealing with land remediation but are part of site development works (stage 1/2 works) so excluding these values this means that the final remediation contract sum was \$389,609 + \$22,458 = \$412,067 (5.7% additional contamination above originally identified as part of the environmental investigations). This figure is seen as quite reasonable given the complexity of the project and the difficulty in quantifying exact volumes.
