Council was successful in this matter and was awarded costs by the Environment, Resources and Development Court (ERD Court). The Development Act also provides Council with the ability to recover costs as a debt from a person in association with the legal action before the ERD Court. The total amount awarded to Council as part of the ERD Court action was \$35,052.34.

- (b) Mr Waye negotiated to repay the costs via a payment plan and commenced regular repayments of \$200/week. When payments ceased unexpectedly, Council proceeded to register a charge against the property to secure payment of the outstanding amount at any time the property is sold. Any amount able to be secured by Council would be after any mortgage had been satisfied.

- (c) Mr Waye renegotiated to commence a new payment plan of \$100/week to pay the outstanding amount of the debt and was making regular repayments.

- (d) Council has recently been advised by Mr Waye that:
- i. He is no longer in a position to make any further repayments
 - ii. He was willing to pay a lump sum payment of \$5,000 to settle his debt
 - iii. The value of the property is now less than the value of the outstanding mortgage
