Background

Section 184(1) of the Local Government Act, 1999 provides the power for Council to sell land if an amount payable by way of rates in respect of land has been in arrears for three (3) years or more.

Every effort is made to ensure a ratepayer enters an acceptable payment arrangement. Phone contact, reminder letters, payment options/arrangements, legal action, letters sent to all registered owners and interested parties are explored prior to the enactment of Councils' rights are sanctioned under Section 184. The Sale of Land for non-payment of Rates is the 'last resort' when rates have been outstanding for a period exceeding three (3) years, all other means of recovering the outstanding rates have been exhausted and no other effective means of collection of rates from rate payers exists.

Discussion

A property situated at 1 Mosswood Close, Mount Gambier described as Lot 194 DP35460 CT5095/591 has an outstanding balance (rates, fines and interest and legal fees) of \$4,190.38 as at 15 January 2019.

The rates have now become outstanding for a period exceeding three (3) years and Council should exercise its right pursuant to Chapter 10, part 1, Division 9 of the Local Government Act, 1999 to seek to sell the land for non-payment of Council rates, fines, etc.

In terms of the disbursement of any funds as a result of the sale of the property, Section 184 (11) of the Local Government Action 1999 provides:

“(11) Any money received by the council in respect of the sale of land under this section will be applied as follows:

- (a) Firstly - in paying the costs of the sale and any other costs incurred in proceeding under this section;*
- (b) Secondly - in discharging any liabilities to the council in respect of the land;*
- (c) Thirdly - in discharging any liability to the Crown for rates, charges or taxes, or any prescribed liability to the Crown in respect of the land;*
- (d) Fourthly - in discharging any liabilities secured by registered mortgages, encumbrances or charges;*
- (e) Fifthly - in discharging any other mortgages, encumbrances and charges of which the council has notice;*
- (f) Sixthly - in payment to the owner of the land.”*

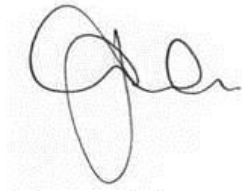
Conclusion

Noting the outstanding rates, fines, etc., owed to Council in relation to the property situated at 1 Mosswood Close, Mount Gambier now exceeds the three (3) years or more provided for under Section 184(1) of the Local Government Act, it is recommended that Council approve proceeding to sale of the property.
