### REPORT RECOMMENDATION

#### **BACKGROUND**

On 21<sup>st</sup> February 2019, Council received a development application, seeking to construct a garage in association with an existing dwelling at 116 Jubilee Highway West, Mount Gambier.

The development application was assessed and processed in accordance the Development Act 1993, Development Regulations 2008 and the Mount Gambier (City) Development Plan (consolidated 21 April 2016).

At its meeting held on Thursday 19<sup>th</sup> September 2019, the Council Assessment Panel resolved the following:

- "1. That Council Assessment Panel report No. AR19/46729 titled '116 Jubilee Highway West, Mount Gambier' as presented on 19<sup>th</sup> September 2019 be noted.
- 2. The applicant and owner be advised that having regard to the Development Plan and all supporting documentation, the proposed development is considered to be at serious variance with the Council's Development Plan and Development Plan Consent be refused.
- 3. The Applicant and Owner be advised that the reasons for refusal are;
  - (a) The wall height and the total height of the garage is excessive and at variance with Council's Development Plan in relation to wall heights of garages;
  - (b) The garage will dominate the streetscape due to its height and size; and
  - (c) The proposed garage won't be sympathetic to the scale of development in the locality."

The Applicant and Owner were advised of this decision via Council correspondence dated 23<sup>rd</sup> September 2019 respectively.

#### DISCUSSION

On 10<sup>th</sup> October 2019, Council received a Notice of Appeal from Frank Brennan (Consulting Services) advising that he is representing the applicant and that an appeal against Council's decision had been lodged with the Environment, Resources and Development Court (the Court) on 10<sup>th</sup> October 2019.

Council has yet to receive the formal notification from the Court in respect of this matter and the scheduling of the preliminary conference.

As the appeal is against a decision made by the Council Assessment Panel, the Council is required to appear before the Environment, Resources and Development Court as part of any conference or hearing.

Elected Members should also note that Council Officers have received threatening and abusive telephone calls from the applicant on this matter.

### CONCLUSION

Council are advised that an Appeal has been lodged with the Environment, Resources and Development Court against a decision made by the Council Assessment Panel. The Council will be defending this appeal, including the engagement of specialist services as required.


