22.2 AF24/218 TENDER - PROCUREMENT - SUPPLY AND DELIVERY OF LANDFILL COMPACTOR (UNIT 41)

CONSIDERATION FOR EXCLUSION OF THE PUBLIC

Pursuant to section 90(2) of the Local Government Act 1999 the Council orders that all members of the public, except the Mayor, Councillors and (Council Officers) be excluded from attendance at the meeting for the receipt and consideration in confidence of AF24/218 Tender - Procurement - Supply and Delivery of Landfill Compactor (Unit 41).

The Council is satisfied that, pursuant to section 90(3) of the Act, the information to be received, discussed or considered in relation to the Agenda Item is:

(k) tenders for the supply of goods, the provision of services or the carrying out of works

The Council is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the information to be discussed in this item relates to a contract between Council and GCM Enviro Pty Ltd.

The disclosure of information in association with this item could reasonably be expected to prejudice the commercial position of Council or confer advantage on third parties and is considered on balance to be contrary to the public interest as it could prejudice the Councils position in obtaining best value on behalf of the community.

PURPOSE

To award a tender for Supply and Delivery of a Landfill Compactor (Unit 41).

SUMMARY OF IMPLICATIONS AND BENEFITS

Implications

 Committing to the purchase of a landfill compactor with associated maintenance and other operational costs.

Benefits

- Maintaining an up to date and fit for purpose fleet of plant.
- Purchase is within budget allocation for the 2024/2025 financial year.
- Estimated short lead time for delivery/changeover of plant item.

BACKGROUND / OPTIONS

Budget

Changeover of Council's existing Tana E260 Landfill Compactor (Unit 41) is included in the 2024/2025 Annual Budget (W76773):

Alias 41 – Landfill Compactor Replacement \$1,050,000

Alias 41 – Income from Trade -\$ 105,000 Net Budget for Changeover \$ 945,000

Tender Process and Submissions

An open tender process was undertaken via SA Tenders and Contracts. At close of tenders on 12 September 2024, submissions were received from four suppliers, a summary of which is as follows:

Evaluation Process

A qualitative criteria assessment was undertaken using previously agreed criteria. This assessment identified the Tana H260 and the Bowmag BC473 as the two preferred options as they:

- fitted the weight range (both were stated to be the optimum size for processing the current and future volumes of waste)
- were both from known reputable brands and offered the best value for money option*.

*It should be noted that the Shantui SR28MR-3 had the actual lowest value for money index following the qualitative criteria assessment, however the machine is not fit for the purpose required and significant deficiencies were identified.

Council currently operates a Tana E260 so are familiar with the brand. To establish the suitability of the Bowmag, staff visited Horsham Rural Council to see the machine in operation (noting that it was a slightly larger model than Council were looking at).

Recommended Tender

The evaluation panel agreed unanimously to recommend the purchase of the Tana H260 Compactor from GCM Enviro Pty Ltd for the following reasons:

- Quality and operator familiarity
- High level of after sales service and excellent working relationship with service provider
- Availability of the Cummins engine in the preferred size model which allows for local expert service and repairs if needed (noting the current unit has over 10,000 hours without any major issues to the engine)
- The Tana has the advantage of a wider single pass footprint due to its twin larger width rollers as opposed to the Bomags 4 x steel wheel footprint

Position Partner Software

The purchase of position partner software is included as a separate item in the budget. Position Partner is a piece of software intelligence that will be attached to the compactor. The tender approached the market for both the software and the compactor, but they are separate purchases and a decision will be made separately regarding the software component. This does not need to be ordered at the same time as the compactor and staff will investigate the options available to determine the most suitable solution.
