BACKGROUND

LGA Procurement:

- 1. **Previous Electricity Supply** Historically Local Government Association Procurement ("LGAP") and expert partners have undertaken competitive tendering for electricity supply on behalf of all SA Councils and several subsidiaries.
- 2. **2022 Process** Further to the tender process undertaken in 2022, Councils were offered the opportunity to accept a contract to supply electricity for six months.
- 3. **Other Procurement Activities** The Rural City of Murray Bridge and City of Mitcham partnered together to combine their profile and approach a different market sector and did not take part in the LGAP tender. It is worth noting that LGA Procurement is working with these Councils in exploring their pilot with their support to incorporate learnings into future procurements for the benefit of the sector.
- 4. **Market Advice** LGAP have advised Council as follows:

Advice from CQ Energy suggest that the volatility in the market that was present late last year has softened and that March/ April is an appropriate time to go to market. CQ Energy and established retailers again reiterate that an aggregated deal is the most attractive method and that our approach to market ensures that all councils receive a reasonable offer and that no council is left behind.

3. **LGA Procurement Plan** – A formal Request for Tender is currently being co-ordinated by "LGAP" on behalf of Councils, expected to be issued to the market in March 2023 with evaluation taking place in May 2023 (with a plan as shown below).



- 4. **Current Contract Expiry** Council's current contract for the supply of electricity expires on 30 June 2023.
- 5. **Council's expenditure** For electricity consumption historically and current year budget (as at BR2 excluding Wulanda) is as follows:

PROPOSAL

- 1. **Tender Response** With the tender option as detailed above Council staff will have limited time to respond to either tender. Council needs to be in a position to respond quickly once negotiations are underway.
- 2. Financial Delegation As the anticipated expenditure is within the Chief Executive Officer's but beyond the General Manager Corporate and Regulatory Services delegation, and it is intended that the final negotiation and execution on behalf of Council will be by the General Manager, Council needs to delegate authority to accept the LGAP recommendation and subsequently enter into a contract. The General Manager Corporate and Regulatory Services is the Chief Executive Officer's nominated delegate for this matter, with General Manager City Infrastructure authorised in his/her absence.
- 3. **Categories** The tender call will invite submissions for pricing of electricity as Accredited Renewable Electricity and Unspecified Electricity. Each source will also need to provide pricing for the following categories:
 - Below 160 MWh per annum (general sites);
 - Above 160 MWh per annum (Civic Centre, Library and Wulanda); and
 - 12 & 24 hour unmetered (street & traffic lights).
- 4. **Tender Scope** The tender will provide the aggregated and detailed load profiles of all participating councils and will request an electricity price based on:
 - "black" electricity plus the mandatory 20% green certificates in the form of large-scale generation certificates (LGCs) or;
 - "black" electricity with 100% LGCs (noting this is an additional 80% LGC procurement above the mandatory option). This provides an option that satisfies a mandatory green procurement option under the Renewable Energy Target (RET) legislation and also provides an option for councils wanting to have a 100% green electricity procurement option;
 - an opportunity from some retailers to provide a reduced electricity usage price if all councils opt for 100% Green Power, which is an option LGAP will also request.
 - LGAP will approach this procurement seeking the best market outcomes for Councils by issuing a formal request for tender to the market.
- 6. **Next Steps** LGAP will be seeking an expression of interest in large, small and 12/24 unmetered sites.
- 7. Once tenders have been received, LGAP will have limited time to accept and/or reject the tenders offered. Within this limited time LGAP will provide its recommendation to Councils for their collective acceptance or otherwise of the recommended offer (expected to be in June 2023). At the request of LGAP, Council needs to be in a position to respond quickly once negotiations are underway.
