Summary:	This report provides an update on the procurement process for Animal Pound and Shelter Services and seeks resolution from Council to extend its current Funding Agreement with South East Animal Welfare League (SEAWL) while this process is underway.

TYPE OF REPORT

BACKGROUND

City of Mount Gambier (Council) has an Agreement with South East Animal Welfare League (SEAWL) for 12 months, until 30 June 2023. The current Agreement is a tri-partied funding arrangement between Council, District Council of Grant (DC Grant) and SEAWL and has been in place since 1 July 2014. On 24 January 2023, Council resolved that, in accordance with its Procurement Policy, a tender, for a five-year contract term, for the provision of animal pound and shelter services on behalf of Council, be issued.

On 21 March 2023, DC Grant received endorsement to proceed to work with us on a procurement process for pound and shelter services and also resolved that their Chief Executive Officer and/or the Director of Environmental Services be delegated the authority to extend the existing agreement with the South East Animal Welfare League with the current terms and conditions for a further 12 months, should it be deemed necessary.

On 28 March 2023, DC Grant and Council met to discuss the procurement approach and confirm where both parties are at. As part of this meeting, it was agreed that we would proceed with an EOI process in the first instance to get a better feel for the market and to help inform an RFQ process. Both parties are now working through the content for this EOI to inform next steps.

At this stage, it is looking likely that we will not have an outcome to the procurement process by the time our existing agreement with SEAWL expires on 30 June 2023.

PROPOSAL

This is a complex procurement process, but one that will set Council up for success in the provision of animal pound and shelter services into the future.

It is therefore important that we take the time to engage with the market, and better understand interest so that we are better informed for a Request for Quote (RFQ) process.

To give Council time to adequately complete this process, and ensure service continuity to the community, it is recommended that we have the capacity to extend the current arrangement for a period up to 12 months, as deemed necessary.

It is, however, proposed that any contract extension include an update to the KPIs to reflect what is currently being reported by SEAWL and request updates on previously provided information that has not been updated i.e. policies and procedures.

LEGAL IMPLICATIONS

The key legislation that applies to the issues considered in this report is *the Dog and Cat Management Act 1995*.

As per this legislation, impounded dogs are required to be held at a facility for 72 hours. After that, animals are generally transferred to a shelter for rehoming. At this point, it is up to the shelter management to resell/rehome or euthanise the animals.

There are currently no set timeframes for impounded cats. However, it is foreseen that the Act may be amended in the near future to include requirements for cats which would result in the impoundment of cats for at least 72 hours (longer if they appear to be owned).

When an animal is found, identification via registration disks and microchip numbers should be checked and owners should be contacted to arrange return to home as soon as possible. If the owner is unable to be identified or contacted, the animal is impounded by the council in an approved



facility and the animal must be held for 72 hours while attempts are made to reunite the animal with its owner.

Councils are responsible for making satisfactory arrangements for the impoundment of dogs and if they choose to detain cats, satisfactory arrangements for a facility for their impoundment.

Council has a budget allocation for this service.

The current value of the Agreement is \$45,000 per annum, paid six monthly in advance. In previous Agreements, up until the most recent, there have been annual CPI increases.Council may consider whether a CPI increase on \$45,000 per annum would be applicable.

RISK IMPLICATIONS

SEAWL may not be satisfied to enter into an extension of Agreement without longer term certainty on what Council's plans are. It may be that Council needs to factor this into its negotiations, with a view that our default position is a CPI increase allocated to the \$45,000 annual figure.

It is considered unlikely that SEAWL would not agree to an extension of the Agreement, as they are highly dependent on the funding they receive from Council and DC Grant. However, in the event they do not agree to an extension, Council will have a contingency plan for the impoundment of dogs while the procurement process is complete.

CONCLUSION AND RECOMMENDATION

It is, recommended that the Chief Executive Officer have the capacity to extend the current Funding Agreement with SEAWL, as deemed necessary, for any period up to 12 months. As part of negotiating an extension, the Chief Executive Officer may deem it appropriate to apply a CPI increase to the current annual amount of \$45,000 in accordance with previous Agreements.

Any extension to the Agreement may also include an update to the KPIs to reflect what is currently being reported by SEAWL and a request to update previously provided information that has not been updated i.e. policies and procedures.
