Payments to Member Organisations for Junior Sportsperson's financial assistance for period 1 July 2015 to 31 March 2018 amounts to \$51,750 and total payments since 1 July 1988 to 31 March 2018 amounts to \$461,550.

Background

The Annual Exceptional Junior Program provides the resource to acknowledge a junior sportsperson who has displayed the ideals, enthusiasm, skills and abilities to develop their fullest potential in their chosen sport and could advance to the highest levels of achievement.

The Commercial Club's donations to the Junior Sports Fund over many years are a magnificent contribution and we are truly indebted to the Club for their continued support and interest in the Program.

Member Organisations were invited to submit up to two (2) confidential nominations to the Committee in accordance with the guidelines and the application form detail, closing on Wednesday 28 March 2018;

Discussion

As at Wednesday 28 March 2018 the following nominations were received:

(i) Applicant 1

Mount Gambier and District Cricket Association - Nominee Aged 12 years:

Applicant 1 has been highly successful in his chosen sport of Cricket since the age of 7 and has been a regular fixture in the junior and senior teams at Yahl playing his first senior A Grade game at age 10. He was the youngest boy inducted into the Chappell Whitty Academy in 2012 at the age of nine and continues to be a member of the Academy. He is a participant of Tenison Woods College High Performance Sports Program in the discipline of Cricket.

Applicant 1 has been involved in many representative sides playing in the County Black team on three occasions comprising elite boys from across the country playing against elite Adelaide clubs. He has represented the Lower South East SAPSASA team in 2017 and has played in numerous Lower South East representative teams in his age group, captaining the Mount Gambier Gold to victory in the 2017/2018 Kerr Shield Competition. The highlight for Applicant 1 is the Selection in the South Australian U12 State Cricket Team where he played a brilliant tournament finishing with 9 wickets - the second highest number for SA and being identified as a future talent in cricket by the South Australian Cricket Association and invited to play for the Glenelg Cricket Club in their U14 2018/2019 season.

(ii) Applicant 2

Blue Lake Y Swim Club - Nominee Aged 13 years

Applicant 2 is an exceptional young swimmer who shows great potential within the sport of swimming. He has a strong and dedicated commitment to the sport and has the potential to develop into a very successful athlete. He is respectful, coachable, talented and has an extremely healthy work ethic.

With limited facilities here Applicant 2 frequently travels to Adelaide to be coached by a silver level coach to further himself and if he were to win this award it would greatly benefit him to excel in his sport. Applicant 2 has recently achieved 2 National times for breast stroke and is competing in Sydney in April, in 2018. His achievements in the various Championships Tournaments attended are attached.



(iii) Applicant 3

Blue Lake Y Swim Club - Nominee Aged 11 years

At 11 years old Applicant 3 has her sights set on big things. She is incredibly focussed and dedicated to the sport of swimming and her respective club has never seen an 11 year old train as hard and consistently to improve and challenge herself. She is co-operative and coachable and values every piece of advice and learning she receives from all coaches. Her family support her and commit to travelling an immense amount of hours to achieve and strive for her goals. She travels to Adelaide and surrounding regional areas to compete and has been sighted by silver and gold level coaches in Adelaide as being a very successful young athlete in the next few years. To win this award would greatly benefit her to excel in her sport. Her achievements in various Championship Tournaments attended are attached.

(iv) Applicant 4

Basketball Mount Gambier - Nominee Aged 15 years

From a very young age Applicant 4 has displayed undoubted and exceptional athletic ability. Her natural sporting talents have been complemented by a keen desire to succeed at the highest level in a range of sporting fields.

Applicant 4 although young in years is a very worthy recipient not only because of her extremely extensive achievements listed on the attachment but also because of her leadership qualities and genuine care she shows for others.

Applicant 4 also assists with umpiring local basketball and junior training sessions.

(v) Applicant 5

Basketball Mount Gambier - Nominee Aged 17 years

Applicant 5 with his positive personal attributes and athletic ability has impressed the local and SA Country basketball communities. In the past tryouts he has made the most of his opportunities to develop his skills to the highest possible levels.

Applicant 5 is an all round contributor to Basketball Mount Gambier displaying a long term commitment to umpiring and is now a qualified 1C referee.



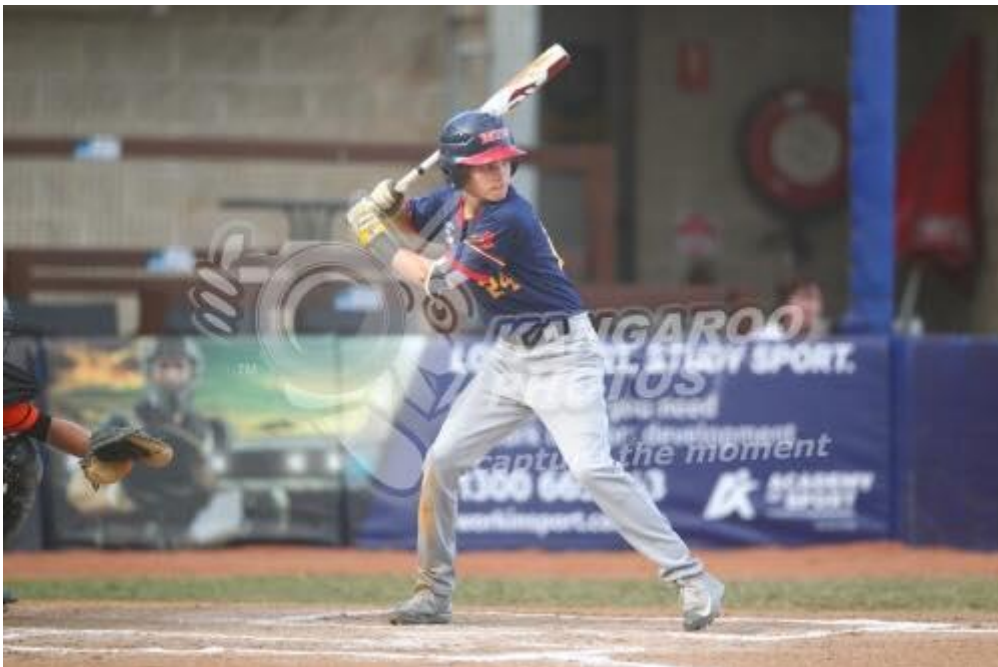
