SUBJECT: 2015 YOUTH WEEK

BACKGROUND

The City of Mount Gambier were successful in gaining 2015 National Youth Week funding through the South Australian Department for Communities and Social Inclusion. This funding is sought annually, and forms the basis for the Youth Week Program each year. Additional funding for activities comes from the Youth Advisory Group and Library Budgets. In total Mount Gambier Youth Week events attracted an estimated 500 people.

The Youth Week program is designed by the Youth Advisory Group (YAG) and is a key component of their community programming annually. Currently the YAG has 15 active members who range in age from 12 to 24 years of age. Working people, students and unemployed young people are represented within the group.

The Library forms a key host venue for Youth Week learning workshops each year, and host the largest Youth Week event – LOUD in the Library. This evening event provides a platform for local musicians and dancers to perform, with a silent disco also operating within the space. During LOUD local service providers connect with young people within a loud, fun, youth friendly environment.

The Main Corner played host to live musicians throughout the week. In Mount Gambier Youth Week has been a vehicle for many musicians to play their first live performance. Youth Week saw nine people perform from the Main Corner this year, leading to a direct approach to one musician to perform at a local café, and calls from members of the public for a number of the performers to begin recording.

A key highlight event identified by the YAG this year, was the 'Let's Talk About Sex(uality)' a late addition to the program. The forum was developed in response to a visit to a YAG meeting by parents who raised concerns about the high suicide rates amongst gay, bisexual and transgender young people in Australia. At this visit the youth Advisory Group decided to host a forum as a platform to safely talk about sexual diversity. The forum received good media coverage, and whilst most of the focus was on young people talking about their experiences, the inclusion of Adelaide based support group PFLAG (Parents and Friends of Lesbians and Gays) saw families able to connect with them and gain valuable support information. Post forum an information and support group coordinated by local forum speakers has began to gather weekly at Metro to speak, share information and build a local support network for other people from the LGBTIQ community.

Lifelong Learning Sub-Committee Report No. 2/2015 cont'd...

Youth Week 2015 saw increased attendance at events by people with a disability. In response the Youth Advisory Group have identified resources they have designed which can be shared with community access agencies to benefit community connections for people with intellectual disabilities in fun ways which are dignified and pro-active.

As a result of activities run this year, the Youth Advisory group has received additional membership requests, primarily from a younger youth cohort.
