#### REPORT RECOMMENDATION

- That Regional Sport and Recreation Centre Committee Report No. AR19/31149 titled 'Community and Recreation Hub - Strategic alignment Tennis SA' as presented on 01 July 2019 be noted.
- 2. That Council accommodate the request from Tennis SA / Tennis Australia to include the Olympic Park Tennis Court and Lighting Refurbishment into the tender specification for the Recreation Hub as an optional item, subject to the provision of relevant detailed specifications to Council including in-kind professional and intellectual support.
- 3. That a further report be presented to Council to consider the tender costings received for the Tennis Refurbishment items, together with funding commitments from Tennis before committing to any associated tender components and funding toward the proposed works.

#### **BACKGROUND**

The Community and Recreation Hub has successfully secured Federal and State Government funding in part because of the qualitative and quantitative benefits that were proposed for sporting groups, aquatics and community health and wellbeing. In addition to the broad merits of the project there may be additional benefits to be secured from bringing large scale state or national entities to the region for construction activities.

In particular, ongoing discussions with Tennis SA has resulted in a proposal to lever from the anticipated Council tender for construction to include an optional additional refurbishment of the adjacent tennis courts. A larger proposal for refurbishment has been recently supported by Council in November 2017 and while Tennis SA has not yet been successful in securing funding and Council has no funding commitment to the refurbishment at present, attempting to secure cost advantages for a modified program of refurbishment will involve no cost to Council and may provide a significant advantage for the strategic plans of Tennis SA.

Representatives of Tennis SA and Tennis Australia met with General Manager City Growth and Manager Executive Administration on 18 June 2019 recognising that the new Community and Recreation Hub has significantly changed the landscape and site opportunities since the time of the previous proposal. They are seeking to work collaboratively to secure a shared solution for a community asset, whilst understanding that an optional addition to contract specifications provides no guarantees of funding form Council. Tennis SA is seeking to lever from current developments to provide information with which to secure funding based on a site consolidation plan.

#### DISCUSSION

From 2012 to 2017 continued efforts toward the resurrection of Olympic Park have been progressed by the peak tennis bodies, Tennis SA and Tennis Australia, and over time presented in many different forums ranging from the Mount Gambier and District Tennis Association (MGDTA), the local community, District Council of Grant and the City of Mount Gambier.

The "Mount Gambier and District Tennis Strategy" was prepared by Tennis SA with the support of the MGDTA, the City of Mount Gambier and Tennis Australia in November 2016. This document identified the potential future demand for tennis across the region, reviews of the current network of tennis facilities, management and use, and future infrastructure requirements.

The progression of this strategy has led to a group of three clubs (Centrals, Mil Lel and Uniting Church) committing to an in-principle expression of interest to form a single body with the view of making Olympic Park their new home.

A proposal to upgrade the Olympic Park tennis courts was presented to the City of Mount Gambier during a workshop in March 2017 with an "in-principle' commitment given by the City of Mount Gambier in November 2017 to fund \$400,000 (ex GST) on the condition that other funding be secured for the full remaining cost of the project.

The Council resolution in the report was as follows;

#### 13.3 Olympic Park Tennis Proposal - Report No. AR17/43678

- (a) That Strategic Standing Committee Report No. AR17/43678 titled 'Olympic Park Tennis Proposal' as presented to the Strategic Standing Committee on 13 November 2017 be noted.
- (b) That Council commits a \$400,000 financial contribution toward the Olympic Park Tennis Redevelopment Proposal to be funded from Council's Cash Advance Debenture facility and/or capital budget over the 2018/2019 and/or 2019/2020 financial years conditional upon the proponents securing full funding commitments for the estimated \$1,200,000 proposal.

(c) The Chief Executive Officer and Mayor be authorised to negotiate and execute funding, development and land tenure agreements for the proposed development of the Olympic Park Tennis Facilities.

This 2017 proposal has not yet been successful in securing funding and with significant sport funding being allocated to the Hub project by the State Government, Tennis SA is hoping to benefit from efficiencies that may be gained via a site integration perspective.

The following represents the details of discussions held with Lynton Franzi - Manager Major Projects Tennis Australia, and Brett Hidson – Manager Venues and Government Relations Tennis SA at the meeting held on 18 June 2018.

In light of the commitment to the Community and Recreational Hub, it is proposed that the following high level Tennis Upgrade scope be included in the construction tender for the overall Community and Recreation Hub precinct.

- Reconstruction and realignment of the courts to deliver 10 tennis courts
- Replace and repair the required fencing to deliver black powder coated poles with black PVC chain-wire fencing around and within the facility
- Re-establish court lighting using latest LED lighting technology

Tennis Australia and Tennis SA are prepared to offer in kind professional and intellectual support to determine operational considerations of the potential integration with the project and to prepare the necessary specifications for a tender proposal.

Tennis Australia, through the National Court Rebate, provide financial contributions to infrastructure projects of significance to tennis, in particular projects that will enhance the opportunities for community wellbeing through tennis participation. Tennis Australia currently has seed funding of \$100,000 assigned for this venue should commitment to construction for the Tennis Upgrade be confirmed. The Tennis Upgrade meets the objectives of the Rebate and the *Tennis SA Places to Play Strategic Plan 2019-2022*.

Tennis SA, from 2019/20, following a restructure of the 'Participation' department, will include dedicated staff to service the region by way of a Regional Participation Manager, a Clubs Development Officer and a Schools Development Officer. These positions are expected to be based within the region, making local connections more frequent, which will deliver a greater presence on the current servicing which is currently centrally located in Adelaide.

Tennis SA is negotiating with the Limestone Coast Regional Sports Academy (LCRSA) to introduce a Tennis Program for local elite tennis players to achieve their aspirations. Olympic Park, with a refurbished tennis facility co-located with the Community and Recreation Hub is the logical base for this program.

Predicated on a Olympic Park tennis upgrade:

- A LCRSA Tennis Program will initiate more visits by elite coaches from Adelaide (currently occurring 3 times annually).
- The SA branch of the National Academy will plan visits to Mount Gambier for annual camps
- A wider range of tennis and multi-sport events that include tennis will be available (potential events noted below)

#### Potential Events

A Tennis Upgrade will allow for the return of tennis events that attract high participant and visitor numbers, including junior and veteran (seniors) tournaments of national, state and regional significance are certainly available through Tennis SA. Likewise, complementary tennis courts to the Community and Recreation Hub will place the city in prime position for multi-sports events such as Masters Games.

Olympic Park and the City of Mount Gambier was host to international ProTour tennis events, the Blue Lake International, for over 20 years, which concluded after the 2011 event as the courts deteriorated to an unacceptable level. Players of the ilk of Alicia Molik, Casey Dellagua and 2019 French Open Champion Ash Barty, played in this event.

Along with the potential to again host a ProTour event, the precinct would be suitable for other notable international events such as Junior Davis and Fed Cups and elite training camps.

In addition the proposal has the endorsement of the Limestone Coast Regional Sporting Academy (LCRSA) who is partnering with Tennis SA to have a skill based Tennis program in the Academy. Tony Elletson noted that:

This program will provide talented tennis players (13-18yo) with high level skill based sessions that will enhance their abilities. The goal is to provide the opportunity through skill development and a clear pathway to the elite level of the sport. This program would engage a coach who would ideally be based locally and would need to use facilities that are at the expected level required for state, national and international level players. Currently we do not have this type of facility, in Mount Gambier. If the proposed tennis upgrade was included in the Recreation Hub build, it would mean the Academy could look to base itself at this facility and would use it on a weekly basis throughout the year. The Academy athletes would look to use the pool facility and potentially the gym areas of the Hub as part of their physical based programs going forward also. The LCRSA is excited about adding an official Tennis SA program to the Academy and believes the upgrade of the Olympic Park Tennis Facilities is vital to providing the elite level standard of programs expected by our athletes.

#### **CONCLUSION**

Leveraging from the largest infrastructure project Council has undertaken for the benefit of another key sporting group in the region is a further illustration of how Council could provide multiple outcomes from resources committed to the project.

This report recommends that Council support the request from Tennis SA / Tennis Australia to include the Olympic Park Tennis Court and Lighting Refurbishment into the tender specification for the Recreation Hub as an optional item, subject to their provision of relevant detailed specifications and including in-kind professional and intellectual support.

In supporting this proposal Council should note that inclusion of the tennis refurbishment as an optional component in the tender specification for the Recreation Hub will not commit Council to funding or progressing these works. A further report would be presented for Council to consider the costings received and any funding commitment from Tennis to support this component of works, as long as such works can be delivered in a timeframe consistent with that anticipated for the hub.

#### **BACKGROUND**

As the most significant recreational facility in our region with state-of-the-art aquatic, fitness, sports, cultural, youth, café and crèche facilities it is important that the facility have a name and brand that reflects the aspirations of the community for the facility to be a place that people want to visit, experience and return to.

At the Council meeting on 21 May 2019, Council resolved to undertake a four week engagement program to invite the community to submit their ideas for a name of the new facility.

#### **DISCUSSION**

Community consultation commenced on Wednesday 22 May 2019 and concluded Sunday 23 June 2019, incorporating a feedback period of 33 days.

The consultation period and awareness raising activities of Council resulted in 65 submissions that are attached (Attachment 1) for review against the following criteria:

- They communicate something meaningful,
- They are distinctive, easy to remember, say and spell;
- They can be future oriented e.g. positioned for growth, change and success;
- They are representative of the community and broader region;
- They are reflective of the ancient or modern history of the site or region;
- The name does not represent an individual community member;
- The name is visual i.e. will lend itself to graphic presentation in a logo, in text and in brand architecture.

A number of names submitted are referenced as Aboriginal names however do not appear in the Bunganditj dictionary that represents the Boandik language of the traditional owners of the land. It is therefore recommended that selection of any of these names be validated by the Bunganditj Language Reclamation Committee before proceeding to community vote.

Key themes and ideas from the community to guide the process of developing a brand proposal have not been conclusive and the following generalised categories are presented for further discussion:

Place - natural environment Historical Boandik Activity focused Other

#### CONCLUSION

Given the relatively low response Council could consider revisiting naming of the site at a later date when activity and construction at the site has commenced giving visibility and interest which may improve the response rate.
