# Background

Council sought to engage an architectural firm for the Mount Gambier Regional Sport and Recreation Centre. The engagement of an architect would provide intermediate drawings required for funding grants, and provide full architectural and construction drawings in the event that funding is successful.

To engage an architectural firm a two stage procurement process was used. The first stage required the lodgment of an Expression of Interest to outline capability/capacity to undertake the work required.

There were 21 complying Expressions of Interest received by the due date of 1<sup>st</sup> June 2018 and in accordance with Council's *P420 Procurement, & Disposal of Land and Assets Policy* each submission was assessed individually by a panel comprising three Council Officers and the Elected Members of the Regional Sport and Recreation Centre Committee.

All documents were kept in confidence and individually assessed against a pre-determined and documented set of criteria. Shortlisted architectural firms were endorsed by Council on 19<sup>th</sup> June 2018 and were subsequently invited to tender for the project which included both a written submission and attendance at Council offices for a mandatory presentation/interview.

#### Discussion

Tender documents were received from the shortlisted architectural firms (one of which formally withdrew from the process) by the due date of 4<sup>th</sup> July 2018. Written submissions were provided to the Evaluation Panel, which included members of the Regional Sport and Recreation Centre Committee, along with an evaluation matrix for assessment.

A summary of the evaluation and pricing is presented in the tables below:
