REPORT RECOMMENDATION

1. That Council Report No. AR20/33430 titled 'Community Development Fund applications' as presented on 09 June 2020 be noted.
2. That Council endorse the following applications and amounts including the shortfall of up to \$55,0000.00 from the Community Development Fund:
 - (a) Lower South East Hockey Association (\$20,000.00)
 - (b) South Gambier Netball Club Association (\$20,000.00)
 - (c) Basketball Mount Gambier (\$20,000.00)
 - (d) Mount Gambier City Band (\$15,000.00)
 - (e) Mount Gambier History Group (\$17,860.00)
 - (f) Senior Citizens Club (\$20,000.00)
3. That Council do not endorse at this time the application from the South Gambier Cricket Club, pending the preparation of a Masterplan for the Blue Lake Sports Park and consideration of tenure arrangements.
4. That the Community Development Fund close for applications effective immediately.
5. That the Chief Executive Officer write and inform the seven groups of Council's decision.



BACKGROUND

The Council has received 13 further applications at the time of writing for support from the Community Development Fund, including:

- Lower South East Hockey Association for installation of solar system on clubrooms (\$20,000.00) [**Attachment 1**];
- South Gambier Netball Club Association for construction of a third netball court (\$20,000.00) [**Attachment 2**];
- South Gambier Cricket Club for construction of a storage shed (\$13,695.00) [**Attachment 3**];
- Basketball Mount Gambier for building fire safety upgrades (\$20,000.00) [**Attachment 4**];
- Mount Gambier City Band Hall for projection and sound system upgrades (\$15,000.00) [**Attachment 5**];
- Mount Gambier History Group for installation of a new ceiling and cupboards (\$17,860.00) [**Attachment 6**];
- Senior Citizens Club for removal and replacement of asbestos flooring and replacement of a door (\$20,000.00) [**Attachment 7**];
- A further six (6) minor applications not exceeding \$5,000, five (5) approved by the Chief Executive Officer under delegation, one pending further information.

As at Wednesday 3 June 2020, the Community Development Fund has supported seventeen (17) projects [**Attachment 8**] totalling \$138,572.46 and currently has \$61,427.54 available, not including development application fees or the requests under consideration in this report.

DISCUSSION

Seven applications for major funding (exceeding \$5,000) require a decision of Council. The seven applications are consistent with the criteria and intent of the Community Development Fund.

All seven applications have been referred to the Manager Executive Administration and the Development Team for preliminary advice relating to landowner consent and development requirements. Following this initial assessment, the following information has been provided to assist Council in their decision-making:

Lower South East Hockey Association

- Planning consent will most likely be required;
- Building rules consent required; and
- No property concerns, providing as-constructed plans are provided to Council, contractors are properly inducted and works are carried out in line with development requirements.

South Gambier Netball Association

- No planning consent required;
- No building rules consent required; and
- No property concerns, providing contractors are properly inducted and works are carried out in line with development requirements under the supervision / responsibility of South Gambier Football Club as Lessee.

Basketball Mount Gambier

- No planning consent required;
- Building rules consent required; and
- No property concerns, providing as-constructed plans are provided to Council, contractors are properly inducted and works are carried out in line with development requirements.



Mount Gambier City Band

- No planning consent required;
- No building rules consent required; and
- Land is not owned by Council.

Mount Gambier History Group

- No planning consent required;
- Building rules consent required; and
- No concerns providing the Reidy Park Centre Management Group, as the tenants are agreeable.

South Gambier Cricket Club

- Planning consent required;
- Building rules consent required; and
- There are currently no tenure arrangements in place with the applicant for this area.

In light of this lack of tenure, it is recommended that this application **not** be supported at this time and that South Gambier Cricket Club be referred to discuss the proposal further with the Mount Gambier and District Cricket Association and the Lower South East Hockey Association as part of the Blue Lake Sports Park Master Planning exercise.

Mount Gambier & District Senior Citizens Club

- No planning consent required;
- No building rules consent required; and
- The works associated with this application were identified during, but were beyond the scope and budget of the tenancy re-location works undertaken by Council in association with the Community and Recreation Hub for the Senior Citizens to accommodate the displaced Open Door Baptist Church in their James Street facility.

The replacement of the asbestos floor tiling is considered to be priority works from a health and safety perspective, noting the 'end of useful life' status of the tiling and the regular usage of the Hall, including by vulnerable persons.

The flooring, together with the door/frame replacement (together with energy efficient lighting – as part of a separate minor round grant application) would enable the completion of ancillary works identified during the recent fit out and building fire safety upgrades.

Whilst the responsibility of the tenant, it is considered unlikely that these works could otherwise be self-funded in the foreseeable future, whereas the need for replacement will increase.

The quotation received is from the contractor engaged by Council to undertake earlier fit out works, who is accordingly familiar with the site and has the capacity to conduct the works in a safe manner and to work in conjunction with the tenants to complete the work in a timely manner with regard to their COVID-19 restrictions and allowable activities.

Accordingly, these works are recommended for grant approval.



CONCLUSION

With \$61,427.54 available Council may now determine whether to release further funds as requested by applicants for the major funding stream. If Council were to endorse all seven applications, the \$200,000.00 budget would be exceeded by over \$65,000.00. At the current time, it is believed that this additional funding can be taken from the COVID-19 funding, as the priority of other projects has diminished given State and Federal Government activities.

In considering the preliminary advice provided by Council officers and the intent of the Community Development Fund the below applications are recommended for approval:

- Lower South East Hockey Association (\$20,000.00);
- South Gambier Netball Club Association (\$20,000.00);
- Basketball Mount Gambier (\$20,000.00);
- Mount Gambier City Band Hall (\$15,000.00);
- Mount Gambier History Group (\$17,860.00); and
- Senior Citizens Club (\$20,000.00).

Approval of the above grant requests (\$112,860.00) will result in a shortfall of over \$50,000.00. This amount may vary depending on clarification around the GST component of grant requests.

It is recommended that the South Gambier Cricket Club reapply for this project to be funded under a future Sport and Recreation Major Capital Works Program following discussions with the Blue Lake Sports Park Working Group.

COMMUNITY DEVELOPMENT FUND

What is the rationale of the fund?

Quick injection of finance into repairs / maintenance of community and sporting facilities, which can be undertaken whilst the facilities are not in use because of the COVID-19 pandemic. This fund is about getting work done ***NOW*** in preparation for a return to community gatherings and sport. The stimulus is expected to flow back in to the community because of the need to source labour (including volunteers) and materials locally. The Council intends to make decisions quickly on applications and will consider increasing the funding available should demand outstrip supply. Preference will be given to projects which work to address compliance issues including disability access to facilities.

How much is available?

Up to \$200,000 is available as part of the fund.

Is match funding required?

No, but it may help your application (particularly on larger projects) and will help the limited funding available to go further, benefiting more in our community.

What are the funding streams?

Minor works – up to \$5,000.

Major works – up to \$20,000.

What are the criteria?

- ▲ Available to community and sporting clubs based in or predominantly serving residents of Mount Gambier.
- ▲ Available for facilities owned by the community or sporting club or facilities rented from the Council.
- ▲ Preference will be given to applications that demonstrate use of local suppliers, contractors and Australian made products.
- ▲ All work to be completed within one month from the date of agreement, unless otherwise agreed in writing.
- ▲ Only one application from each of the funding streams.
- ▲ Funding from the Community Development Fund cannot be used to match fund other City of Mount Gambier grants requiring a group / club contribution.

How to apply?

- ▲ **Minor works** – Complete the application form overleaf and submit to city@mountgambier.sa.gov.au with a quote from a local contractor and / or supplier.
- ▲ **Major works** – Complete the application form overleaf and submit to city@mountgambier.sa.gov.au with a quote from a local contractor and / or supplier and a statement of the benefits to the community from the Council's investment in the project and whether the club / society is proposing to put any funding towards the work (max. 250 words).

If the works require other consents (Landlord Consent / Planning Approval) we will work with you to help you achieve these and will waive our fees for this work.

LOWER SOUTH EAST HOCKEY ASSOCIATION (LSEHA)

City of Mount Gambier Community Development Fund Application statement.

The LSEHA would like to thank the City of Mount Gambier for the opportunity to submit for funding the upgrade of the existing Public Address system along with Grid connect solar.

'Statement of Community Benefit'

With over 500 registered players with our association, the proposed upgrades to our facilities offer both instant and ongoing benefit to our membership and supporters.

Using local 100% owned local business, Sonic Vision & Watersolve Irrigation have submitted value for money quotations for the upgrade and improvement of our facilities which will benefit 100% of the membership.

The Proposed installation of a 15kW grid connect solar system will assist in reducing the \$16,000 annual electricity costs, offering close to a 4-year payback on the investment.

Addition to the solar system, we are looking to upgrade the existing Public Address system that was found wanting last season due to its age, condition, and lack of clarity. The 2020 season will be running under restrictions and its upgrade will prove valuable in administering and updating membership during trainings as well weekends.

The LSEHA offer to contribute to the purchase of the proposed upgrades past the \$20,000 offered by council as well as the 'in-kind' contribution associated with the P/A system installation.

'Background'

The Lower South East Hockey Association (LSEHA) is a stakeholder of the Blue Lake Sports Park and enjoys a fantastic relationship with city council. Last season the LSEHA had over 500 memberships along with family and supporters, most of whom reside in the City region.

As an association, we have a unique model in which all participating clubs use the LSEHA facilities which is essentially a social & community hub for all involved. While on the field, clubs compete vigorously, we have great comradery off the field and many friendships are formed between clubs.

The LSEHA take much pride in our economic model. The LSEHA installed a Water based turf 30 years ago and since this time, have seen the turf and ancillaries upgraded 3 times. A majority of this has been paid for directly by the LSEHA due to the strong economic management of the facilities and competition.

We have attracted the attention of Hockey SA with our continuous success at state carnivals as well as representation at State Level. Hockey SA recently ran a training camp at our facilities which attracted close to 40 representatives' coaches and family members to our region. We also boast local coaches who are currently coaching at state level within Hockey SA. Our dream is to have LSE talent represent once again at National level, with the most recent being our association president Lochie Nisbett captain the Australian U/21 team.

I have joined the executive committee this year taking on the role of facilities manager. The executive budget funds annually for the maintenance and upgrade of the facilities. This year we have held back on any major works proposed due to the uncertainty.


One of our priorities this year were to upgrade the Personal Address system. During last season's grand finale, we discovered the existing system was not working to capacity nor with any clarity. With restrictions expected for this season, the upgraded P/A system will provide us with more resources toward administering restrictions at training and on game days. Sonic vision has recommended the attached system upgrade quotation for a total of \$7,837.00 GST inclusive. Excluded from these works are an 'in kind' agreement in which LSEHA will be responsible for the installation of both cable & conduit to support a speaker at the Northern end of the field.

With an annual cost of electricity exceeding \$16,000.00 p/a Grid connect solar makes a lot of sense at our facilities. Having operated within the grid connect solar industry for some 8 years, my experience has assisted in the review of the benefit of grid connect solar at our site. With a total spend of \$18,483.00 GST inc after STC discount, this spend will be recovered with 4 years.

The total value of this application is \$ 23,927.45 + GST. With the maximum \$20,000.00 on offer, the LSEHA is willing to commit \$ 3,927.45 to make up the shortfall along with the 'in-kind' works associated with installing the P/A system.

RE: Community Development Fund Application 2020,

The South Gambier Netball Club (SGNC) has been an important part of the local community for over 30 years and has experienced significant growth in recent years. However, without the appropriate infrastructure and facilities to support sport and physical activities many of the associated community benefits wouldn't be realised. The Construction of a third netball court will have the following benefits to the Mount Gambier Community:

- Provide a better quality, safer and more accessible sporting facility for the over 500 players that compete in the Western Border Netball Association and the greater Limestone Coast community, along with their families and friends who support them. Community sporting infrastructure enables meaningful connections through various social interactions at these facilities, both on and off the field, building safer and more inclusive communities.
- Increase access to the courts and allow other community groups, schools and sporting organisations to utilise the club's facilities.
- Bring the SGNC in line with Netball SA court standards enabling us to host elite athletes and attract regional/state and national events to Mount Gambier. An additional court will complement the two newly resurfaced courts, increasing our chances of attracting regional, state & national events to Mount Gambier, which will have a direct economic impact to the community and supply chain as a result of event activities. (ie increase in accommodation nights booked, contracting of local service providers, employment of local workforce, procurement of locally produced products)
- Sport and recreation is crucial to maintaining a healthy, active lifestyle. An additional Court will increase the number of players who can and will now play sport utilising our new facilities. This leads to a healthier, more active community, which in turn provides savings to our local health system as a result of lower incidences of disease and improved mental health and wellbeing outcomes. 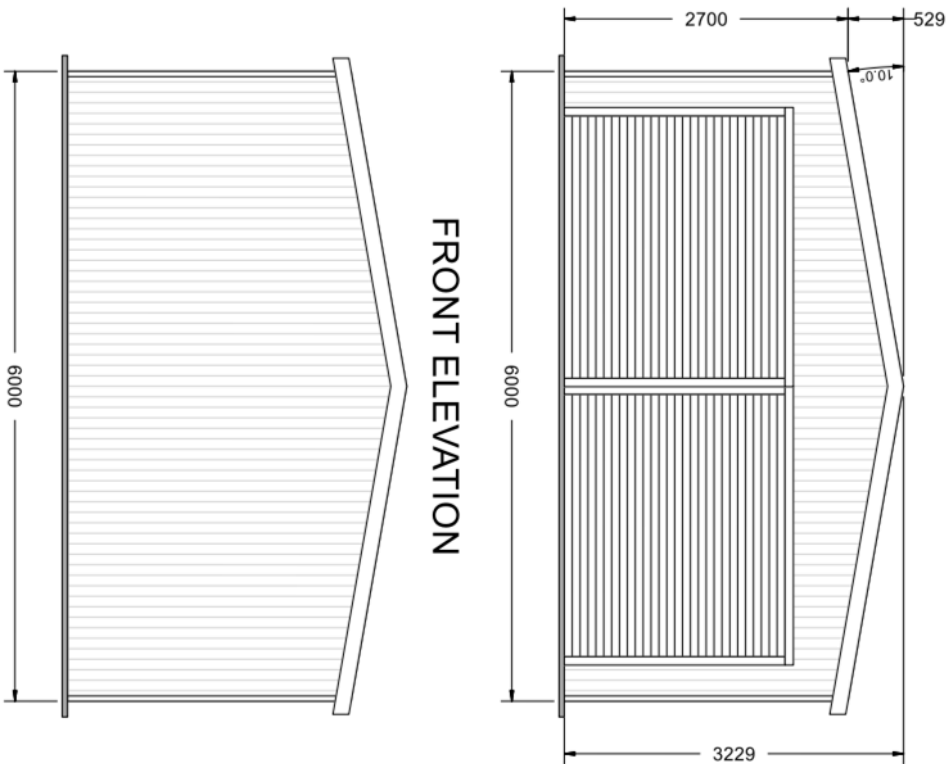

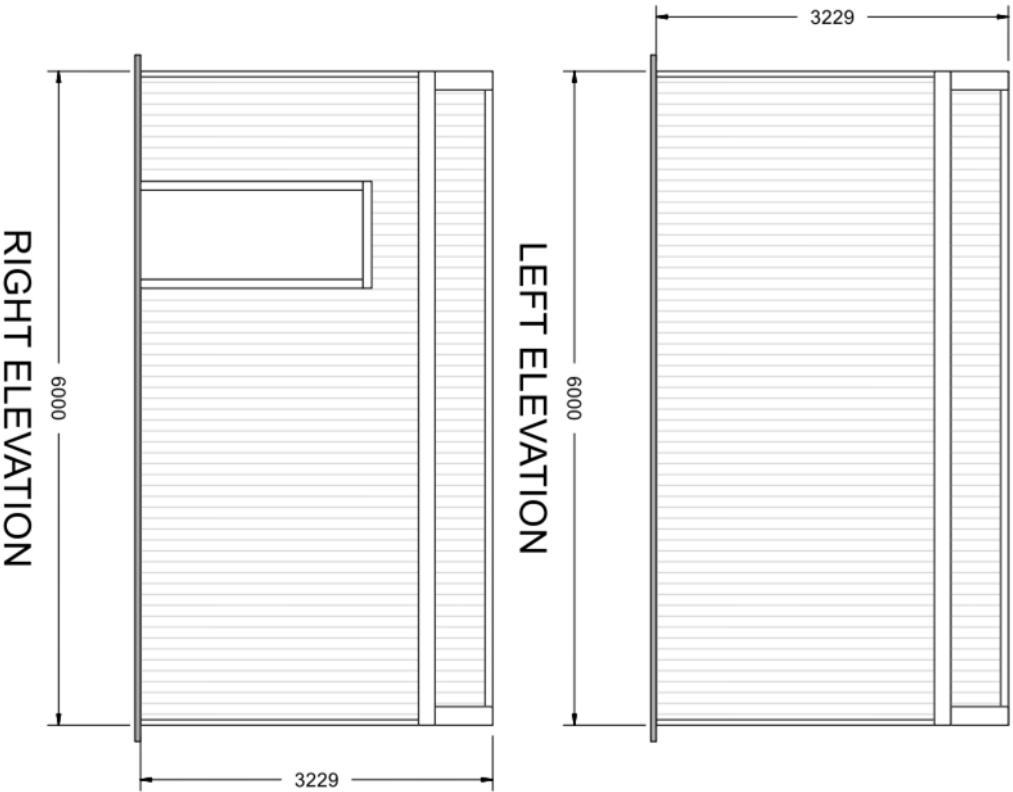

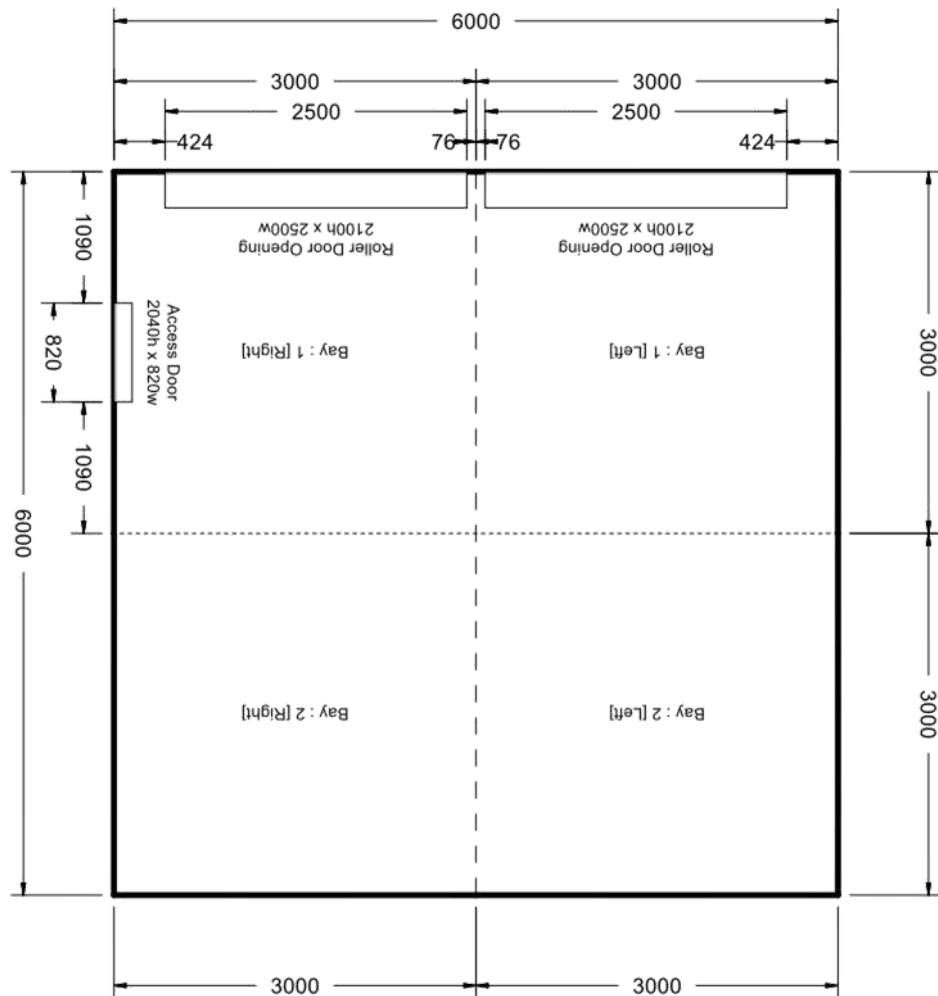

Statement

The Covid19 health emergency has prevented general use of the hall, including all activity of the **Mount Gambier City Band**, the **Mount Gambier City Concert Band** and the **Limestone Coast Symphony Orchestra** who regard the hall as their home. The City Band Hall has also been unavailable for hire, with subsequent loss of income.

During lockdown, a group of interested volunteers have been working singly and in family groups to **raise funds and upgrade the interior of the hall**. A total of \$5,000 was raised by volunteers before and during lockdown to finance this work. When completed it will compliment the kitchen and bathroom upgrade undertaken in 2018-19 which included **disability/wheelchair bathroom facilities and entrances**.

Since mid March the interior of the hall auditorium, the stage, foyer and club-rooms have all been renovated and painted. The former bathrooms situated either side of the stage have been decommissioned and converted to storage rooms. This work has been carried out by around fifteen volunteers and both pro bono and paid tradesmen.

The aim has been to upgrade the hall to a modern, clean and well-equipped facility. for hire. We see the addition of an up-to-date audio visual system as the final step in the upgrade, a step which will enhance the hall greatly for a wider range of community activities and improve its prospects for general hire. The committee relies on hire fees for the upkeep of the hall.

Besides band concerts and fundraising activities, we envision increased use for school and church community events, professional education sessions, political meetings, as well as private family functions and visiting school tour groups. Grant High School will use the facility when its Drama/Music block is demolished later this year for upgrade.

The attached grant application is for the installation of **audio visual equipment**, including a fixed **digital projector, motorized screen and sound equipment for audio - visual presentation and public speaking**. 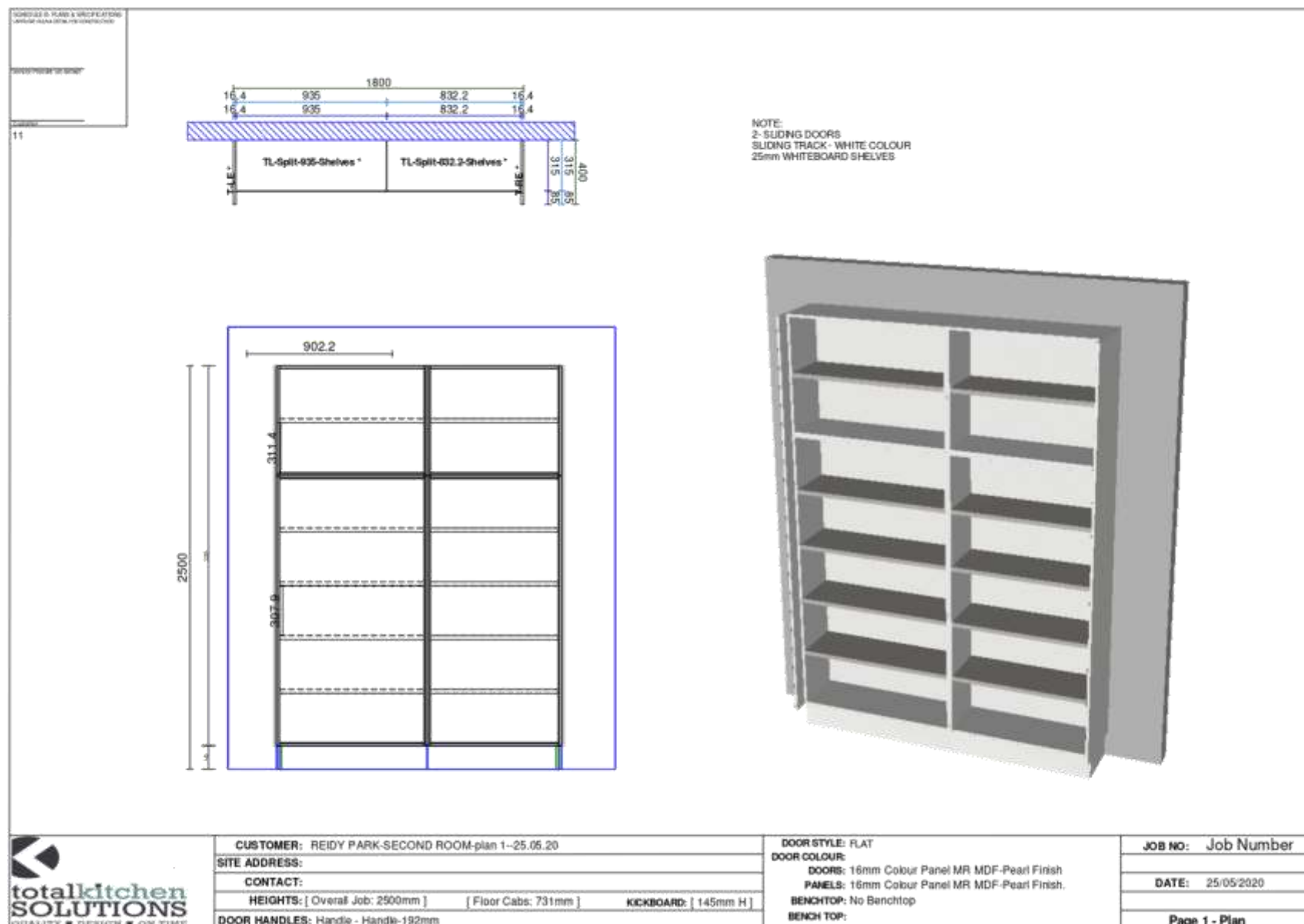

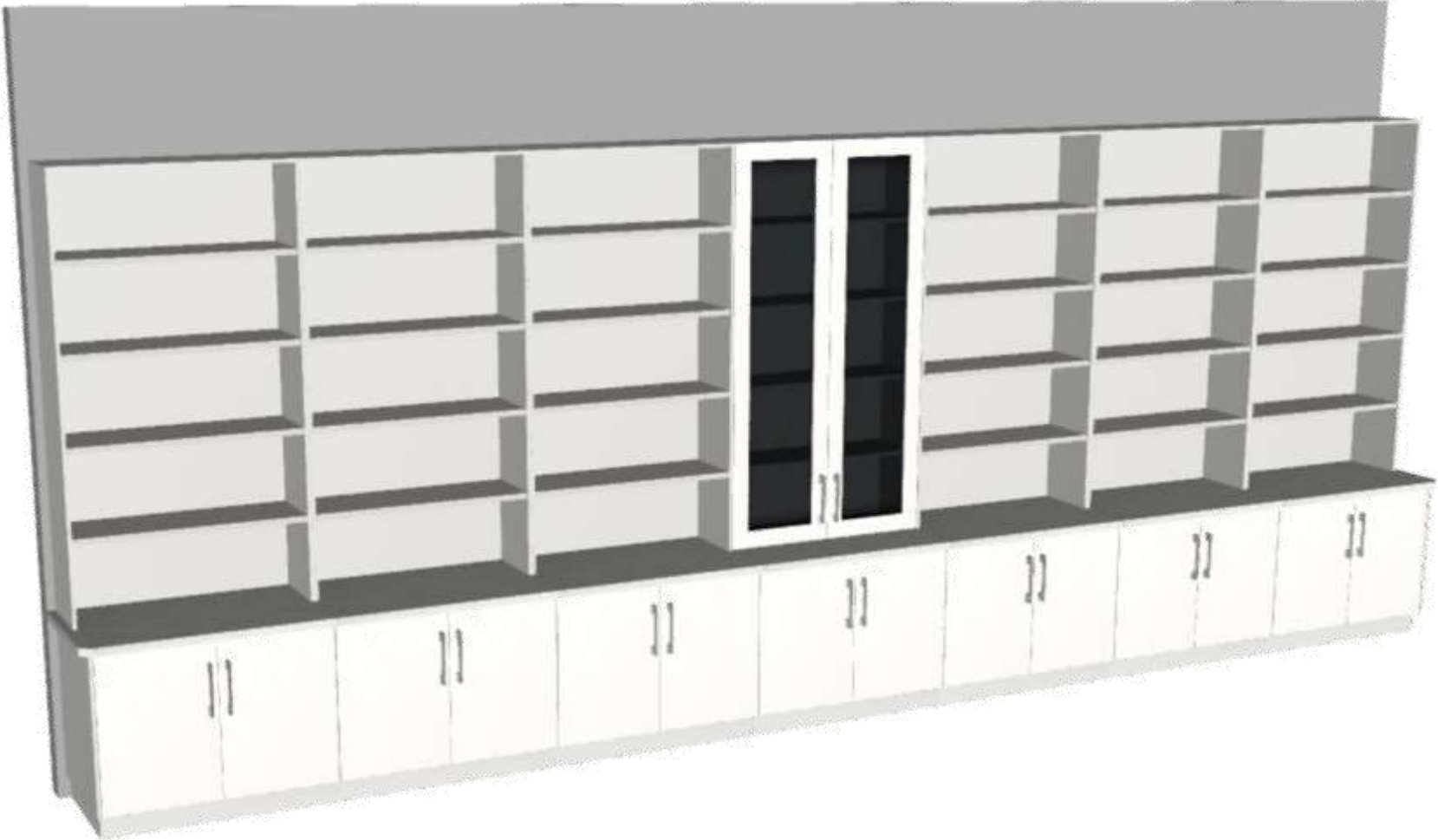

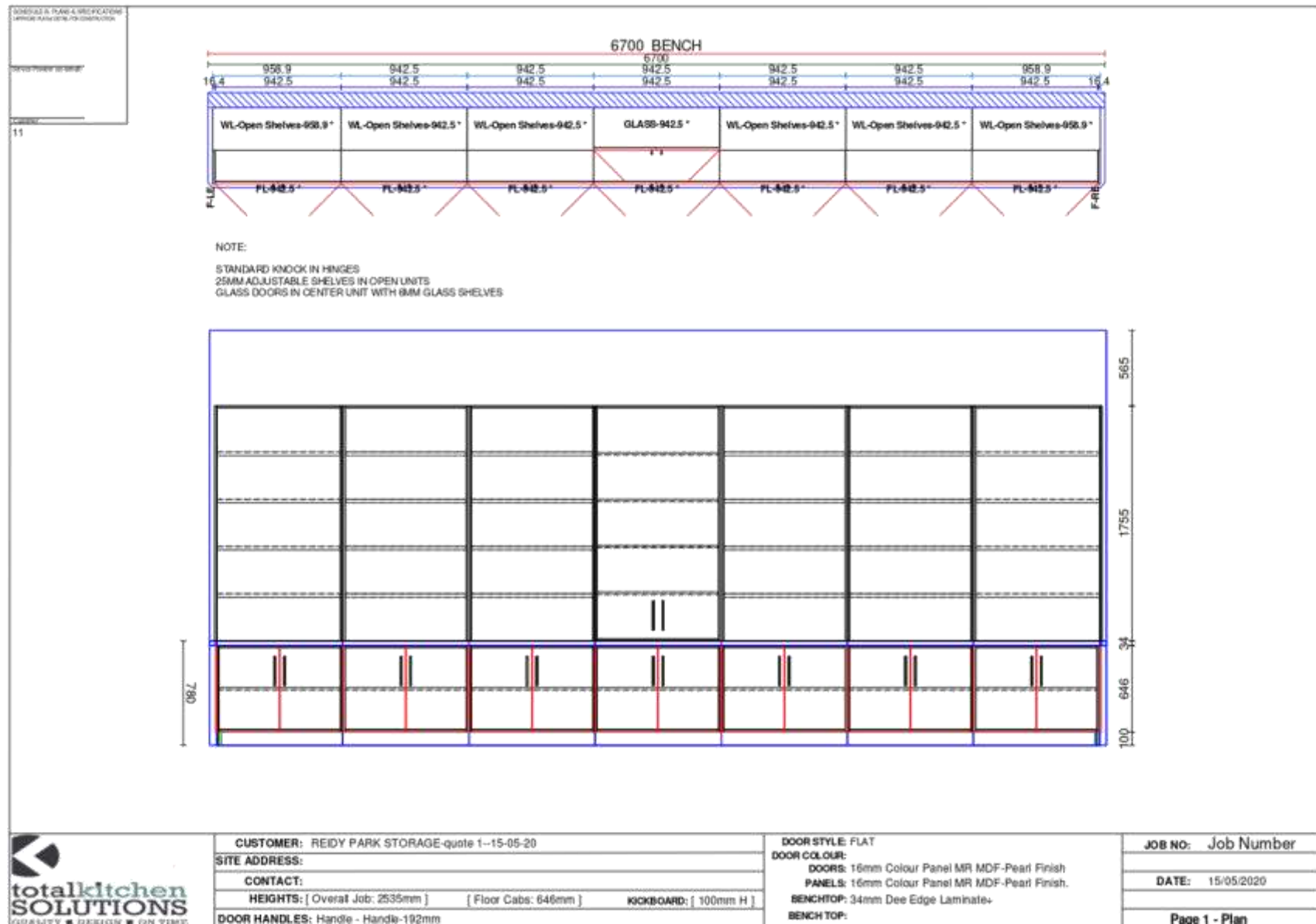
