1. <u>GOVERNANCE</u> – Making a temporary Councillor appointment to the Chief Executive Officer Performance Review Committee

The Mayor reported that over the past several weeks the Chief Executive Officer's Performance Review Committee has been working with Adam Kennedy from AME Recruitment to review the Chief Executive Officer's Key Performance Indicators. This process was a recommendation from the Chief Executive Officer's review report developed for Council by Adam Kennedy and presented to Council late 2013.

The Chief Executive Officer's Performance Review Committee met with Mr Kennedy on 12<sup>th</sup> March, 2014 to consider revised Key Performance Indicators that then guided work by Mr Kennedy for a further attendance in Mount Gambier and presentation to the Chief Executive Officer's Performance Review Committee on 27<sup>th</sup> March, 2014. The Draft Key Performance Indicators have been provided to the Committee Members for consideration prior to the meeting on the 27<sup>th</sup> March.

Due to unforseen circumstances the Chief Executive Officer's Performance Review Committee is not able to achieve quorum to complete this work with Mr Kennedy and endorse the revised Key Performance Indicators. To overcome this situation the Mayor suggests that a temporary Councillor appointment is made to the Chief Executive Officer's Performance Review Committee to ensure continuity of the work done to date.
