

Mount Gambier and District Tertiary Health Education Grants Program

The Mount Gambier and District Tertiary Health Education Grants have been offered every year since 2007 as a response to meeting essential skills shortages within the local health sector. The program supports students who need to leave the region in order to undertake specific university studies within the health sector and seeks to encourage their return to the region as skilled health professionals upon completion of their studies.

Each year, up to 12 grants are made available to new or continuing students. Funds are provided through a unique community partnership consisting of individuals, commercial and community oriented groups.

The grant is available to applicants for use towards supporting their tertiary studies such as travel, accommodation, text books, uniforms, selection tests and communication.

Eligibility Criteria

The Mount Gambier and District Tertiary Health Education Grant, valued at \$2,000 per student, will be offered, conditional upon applicants meeting the following criteria:

- Applicants must have resided in the City of Mount Gambier or the District Council of Grant for a minimum of two years.
- Applicants must be undertaking full or part time studies (minimum of 50% full time equivalent) with a recognised Australian university located outside of the Mount Gambier area.
- Students must be commencing or continuing universities studies in either an internal, external or mixed mode study program, in any of the following identified skill areas:
 - o Medicine
 - o Pharmacy
 - Dentistry
 - Allied health (including but not limited to occupational therapy, speech therapy, dietetics, podiatry, physiotherapy)
 - Chiropractic
 - Midwifery
 - Psychology (Honours only)
 - Paramedicine
 - Mental Health Nursing
 - Other related health programs where there is an identified skill shortage in the Mount Gambier District
 - Only applicants studying courses where there is a direct or demonstrated connection to a health related occupation will be considered.
- If required, applicants must be willing to participate in an interview (personal or telephone) as part of the selection process.
- Applicants must be Australian citizens or permanent residents of Australia.
- Aboriginal and Torres Strait Islander people are encouraged to apply.
- No age restrictions apply.



Terms and conditions

- The total value of the grant is \$2,000 per student, and will be paid after the first Census date (31st March) to the successful applicants.
- Whilst a recipient may apply more than once, it is unlikely that a second grant would be provided.
- The grant cannot be deferred.
- Selected applicants will be made the offer of a grant in writing, subject to the following terms and conditions, whereby the applicant must agree to:
 - provide details of any other scholarships or financial assistance received by the applicant for the current year, by the date specified in the letter of offer.
 - assist with the ongoing promotion of the Grant Program and its acceptance within the wider community by "showcasing" to the community the benefits derived from being a grant recipient,
 - assist in the development of the Grant Program for future years by meeting with the Community Management Group; and
 - submit a Recipients Statement by 30 September detailing how the grant has been utilised and the progression of their studies.
- Providing the applicant agrees to accept the above terms and conditions, a grant of \$2,000 will then be made available.
- The Selection Panel will make a decision on the merits of each application and based on established priorities. There will be no feedback to unsuccessful applicants.
- The Selection Panel reserves the right to offer all or none of the grants, subject to the suitability of applications received.

PLEASE NOTE:

Acceptance of the grant may put at risk eligibility for receipt of other scholarships (eg Smith Family Learning for Life Scholarship). It remains the responsibility of the recipient to ensure eligibility requirements for other scholarships or grants are met.

Grants may, in some instances, be counted as income against Youth Allowance or other forms of government assistance payments. Similarly, students may be eligible for tax exemptions for scholarships. We therefore recommend applicants seek independent financial and taxation advice.
